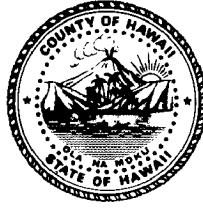

Pursuant to HRS 1-28.5, notice is hereby given that a public hearing of the County Council's Committee on Planning will be held to hear public testimony regarding Bill 324 (Comm. 1329), which amends the Hawai'i County Code 1983 (2005 Edition, as amended), by adding a new chapter relating to impact fees by establishing a newly created Chapter 36 in the County Code entitled Impact Fees, which implements the provisions and requirements for an impact fee.
